



## **About the conference**


#### The purpose of the conference is to:

#### **Professor Sir Steve Smith**

#### International Education Champion, UK Government

Sir Steve is instrumental in driving the UK Government's International Education Strategy, spearheading the UK's international education activity and developing strong partnerships with the UK's key international partners. Sir Steve led the most recent higher education delegation to India in 2019, in his role as Chair of UUK International. Sir Steve has taken part in two UK Prime Ministerial visits to India and, as Vice Chancellor of the University of Exeter, from 2002-2020 and Chair of UUK International from 2013-2020 developed extensive links with Indian institutions and colleagues.

#### Prof. Mamidala Jagadesh Kumar

#### Chairman University Grants Commission (UGC)

Prof. M. Jagadesh Kumarobtained received his MS(EE) and PhD(EE) degrees from the Dept of Electrical Engineering, Indian Institute of Technology, Madras and did his post-doctoral research at Department of Electrical and Computer Engineering, University of Waterloo, Waterloo, Ontario, Canada. He is a Professor in the Department of Electrical Engineering at IIT Delhi.

He is presently the Chairman of University Grants Commission and Professor of Electrical Engineering at IIT Delhi. He was the 12th Vicechancellor of Jawaharlal Nehru University, New Delhi (Jan 2016 – Feb 2022). He held the NXP (Philips) Chair Professor established at IIT Delhi by Philips Semiconductors, Netherlands. He received the 2013 Award for Excellence in Teaching (in large class category) from IIT Delhi.

He works in the area of Nanoelectronic Devices, Nanoscale Device modeling and simulation, Innovative Device Design and Power semiconductor devices. He has published extensively in the above areas with three books, four book chapters and more than 250 publications in refereed journals and conferences. Several patent applications have been filed based on his research.



#### **Professor Agnes Nairn**

Pro Vice-Chancellor and Vice President (Global Engagement), University of Bristol

Agnes is Chair of Marketing, University of Bristol and Distinguished International Visiting Faculty at NMIMS, Mumbai. Her research focuses on the ethics and regulation of marketing to children. She was Special Adviser to the House of Lords for the report UK Advertising in a Digital Age and is Co-PI of the new University of Bristol Gambling Harms Research Hub. She has worked on over 30 international multi-stakeholder projects with public, private and third sector organisations ranging from UNICEF, UN, and Brazilian Justice Ministry to Unilever, Coca-Cola and Public Health England.

Under his watch, the Indo-French strategic partnership was strengthened and consolidated further in spheres such as defense, space, nuclear & solar energy, smart cities and investment. Earlier, Mohan Kumar was India's Ambassador to the Kingdom of Bahrain where he witnessed and dealt with a strategically complex region characterized by events such as the "Arab Spring".

Ambassador Dr. Mohan Kumar has enormous expertise in the area of international trade- he was India's lead negotiator first at the GATT (General Agreement on Tariffs and Trade) and then at the WTO (World Trade Organization) in crucial areas such as Intellectual Property Rights, Services, Dispute Settlement, Rules and Technical Barriers to Trade. He was a leading member of India's delegation at the WTO Ministerial Conferences held in Marrakesh (1994), Seattle (1999) and Doha (2001).

She is the Chief Commissioner for Guides of Bharat Scouts and Guides. She is also the Member of General Assembly and Finance Committee of the Indian Council for Cultural Relations (ICCR), New Delhi.

Dr (Mrs) Pankaj Mittal is a Fulbright Scholar and has been a topper in MSc and PhD in Agricultural Statistics from IARI, New Delhi. Dr Mittal has also served as the first regular Vice Chancellor of Bhagat Phool Singh Mahila Vishwavidyalaya, Haryana, the first rural women university of North India for two terms. Dr Mittal is also the recipient of many Awards and Honours like Fulbright Nehru Scholarship grant for Educational Administrators, President of India Award in 2017 for Digital Initiatives in Higher education, Honorary Doctorate-D. Litt. (Honoris Causa) from Karnataka State Women's University, Karnataka, First Padam Shri Subhashini Devi Award 2018 for contributions in Societal Development and Community Engagement, Qimpro Gold Standard Award for leadership in Education for the year 2018 and Smt. Sushma Swaraj Stree Shakti Samman 2020.

Richard is Associate Pro-Vice-Chancellor, International and works closely with the rest of the International team to coordinate the strategy around the University's global activities. 


#### Rajendra Tripathi




#### Vinod Singh Yadav


