#### **Association of Indian Universities**

- Saddler Commission in 1919, Government of India convened for the first time a "Conference of Indian Universities" at Shimla in May 1924
- Inter University Board 1925 was established which was renamed as AIU in 1967 with representative of Govt of India as Witness
- Largest Association of the Universities in the world with membership of 963 Indian and Foreign Universities

#### Foreign Qualifications

- AIU has been according equivalence to degrees awarded by the Foreign accredited School/Universities since 1925 for higher education purpose.
- Gol (MHRD) vide their O.M. No. F.15-17/94-TS.IV dated 13th March, 1995 has decided to valid the equivalence given by AIU for purpose of employment in Gol.

#### Indian Qualifications

- Equivalence of Indian School Boards as per Gazette Notification No. F.11-3/2016-Sch.3 dated 15.11.2021.
- Equivalence of Post Grade Diploma Program with an MBA degree of Indian Universities vid MHRD No.12-56/2014-U1 dated 29<sup>th</sup> September 2014.

#### Mapping of Foreign School Qualifications

Mapping of all Major School Education system viz International Baccalaureate (IB) Examination, USA High School Diploma, UK Examination Boards, European/Spanish /French Baccalaureate Examination, Australian School Boards with Indian Education System.

12 years School Examination approved by Ministry of Education of various Countries.

## Equivalence of foreign degrees is established on the basis of the following parameters

are awarded by the foreign universities which are approved/ recognized/accredited in its own country:

(References: IAU, UNESCO, ERIC-NARIC Network/ High Commission/Embassy/AIU database)

The minimum eligibility requirements for admission in the programme of studies is at least the same as applicable in case of Indian Universities;



#### **Broad Parameters for Equivalence**

- The minimum prescribed duration of the programme of the studies is at least the same as applicable in case of Indian universities OR has obtained minimum number of academic credit as required in the corresponding degree of Indian Universities
- are pursued by a student as a full time/part time on the campus of the university of its Origin/recognized TNE arrangement
- ☐ Exceptions : Bilateral Agreements/ MoUs

#### Process for Mapping New Education System



- Equivalence is established on course to course basis
- Proposal for equivalence of foreign qualification is received through Indian Mission abroad or through the University concerned
- For this purpose the information on the following points is obtained

## Mutual Recognition of Qualification(MRQ) between India & UK

#### Salient Features of MRQ between India & UK



15

- MRQ between India and UK came into effect on 21 Jul 2022
- ☐ The qualifications covered by this MoU are
  - Formal upper secondary qualifications that are typically used to access higher education in the United Kingdom of Great Britain and Northern Ireland
  - □ Indian Senior Secondary/Pre University Qualifications of Indian School Boards
  - Bachelors, Master and PhD degree of recognized institutions of both countries
- Partial/incomplete/Credit Transfer from recognized institutions shall be considered by institution of each other countries and shall be facilitated by the implementation agencies in both the countries

#### **Scope and Mode of Delivery**

- Professional degrees in the fields of Engineering Medicine, Nursing, Pharmacy, Law, and Architecture are out of scope of this MoU
- Qualifications that are delivered partially online and those delivered online due to force majeure will be recognized under the MoU provided the awarding institution has the right to operate in the country where it is based
- ☐ The qualification intended to be delivered fully online will be evaluated on a case-by-case basis

#### Way Ahead

- □ AIU, British Council and ENIC formed a Technical working group to exchange information and work towards smooth implementation of MRQ
- The recognition and establishment of equivalence of the partially completed qualifications. National credit frameworks and NHEQF in place so mapping exercise of the various levels and associated academic credit would be undertaken jointly by AIU and UKENIC.
- □ AIU and ENIC will create a joint document such as a handbook or standard FAQ document for reference by Indian and UK Universities to engage in TNE arrangement

#### Way Ahead

The engineering academic qualifications are presently not covered in the MoU. However, further study shall be carried out to understand the nature of qualifications for mutual recognition

For recognition of online and distance education courses, AIU and UKENIC would develop a mechanism through stakeholders' consultation to ensure quality assurance around the online degrees for recognition
